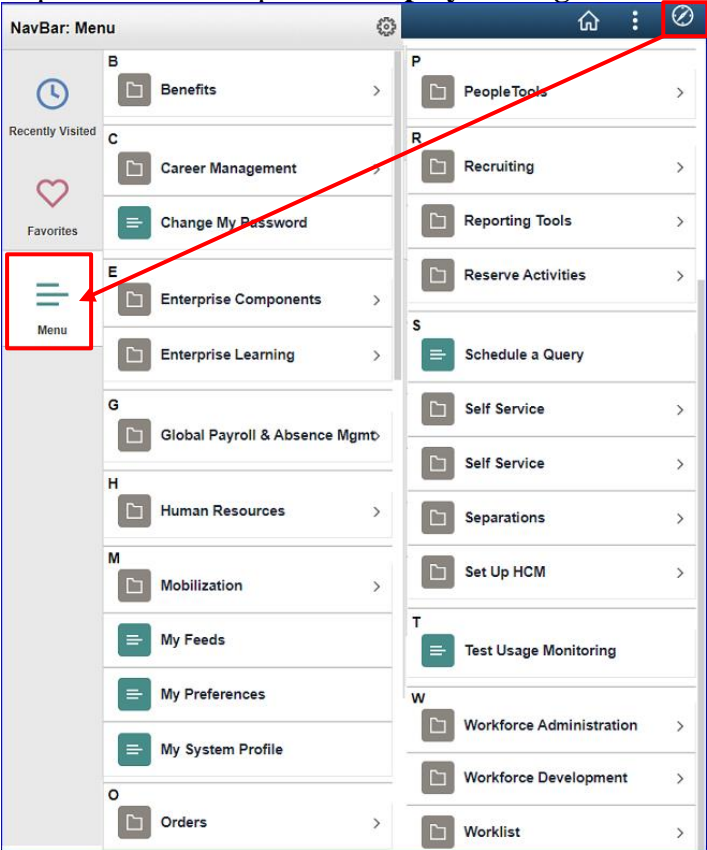
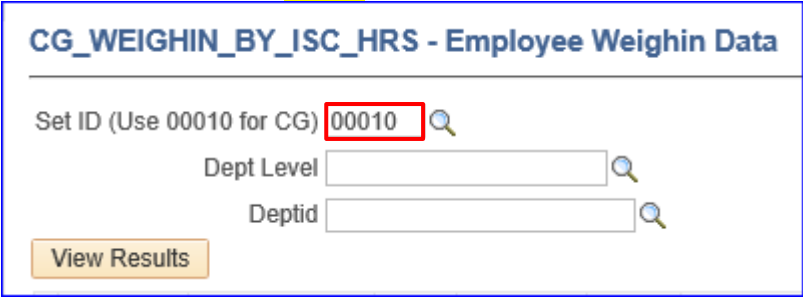


# Member Weigh In Report

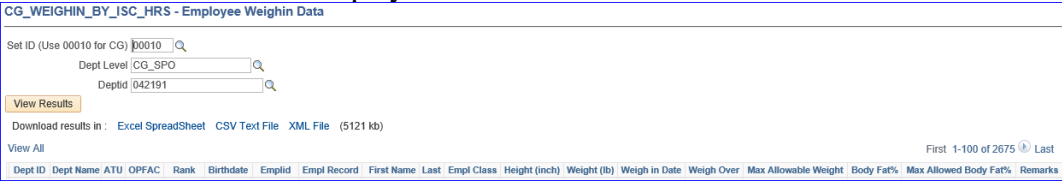
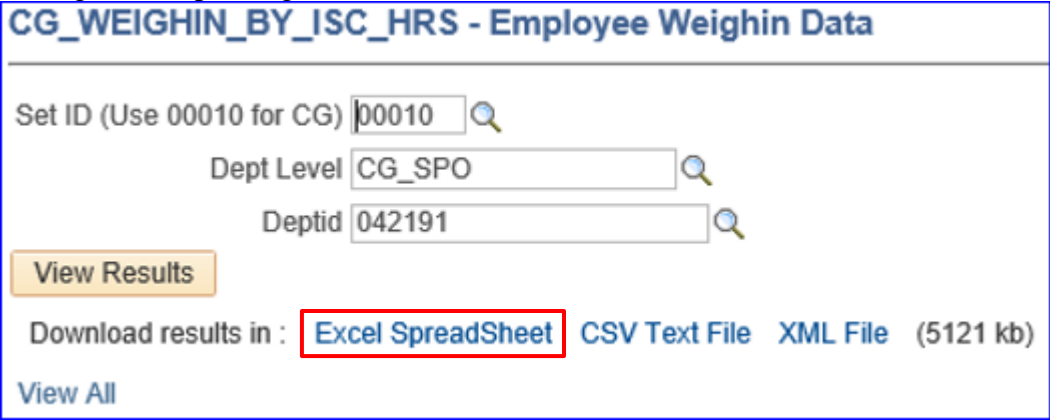
